We are pleased that you have expressed interest in the Integrative and Functional Nutrition Academy Certified Practitioner™ credential. Our goal is that your successful completion of the IFNA™ program and IFNCP™ credential exam reflects the requisite knowledge, skills and abilities necessary to be a competent Integrative and Functional Nutrition practitioner. Eligibility Requirements

Eligible persons are:

1. Health care practitioners (i.e. Registered Dietitian Nutritionists, Registered Nurses, etc.)
2. Dietetic interns
3. Masters or Doctorate level university students in the health science/nutrition field
4. Health coaches, massage therapists, personal trainers and nutrition consultants that have:
 1. acquired a minimum of 1000 hours in clinical practice within a 5-year period and
 2. a minimum of a Bachelor's of Science in Nutrition from an accredited university.

Those with a high level of interest but no formal training are not eligible to apply for the IFNCP™ credential. In cases where eligibility is uncertain, the credential board will determine on a case by case basis. If you have questions about eligibility, feel free to contact us at info@IFNAcademy.com.

Credential applicants must:

- complete all five IFNA™ Tracks
- pass all of the module quizzes
- submit an application (upon completion of the entire program) and a one-time non-refundable application fee of \$149
- pass the IFNCP™ credential board exam

Upon successful completion, student will be awarded the IFN Certified Practitioner™ designation (IFNCP™) and placed in our directory of IFN certified practitioners.

Requirements to maintain and renew certification:

- Maintain your IFNA™ membership annually of \$147 payable to IFNA™
- Acquire 50 CPEUs per five years from the IFNA™ Approved Provider list payable to the Provider directly

Non-refundable IFNCP™ application fee: - \$149

IFNCP™ Credential Exam Fee (includes case study) - \$299

In the case that an applicant wishes to withdraw from the IFNCP™ Credential Exam but has already paid the IFNCP™ Credential Exam fee, a refund less \$50 will be refunded to the applicant within 1 week of notification of withdrawal.
